

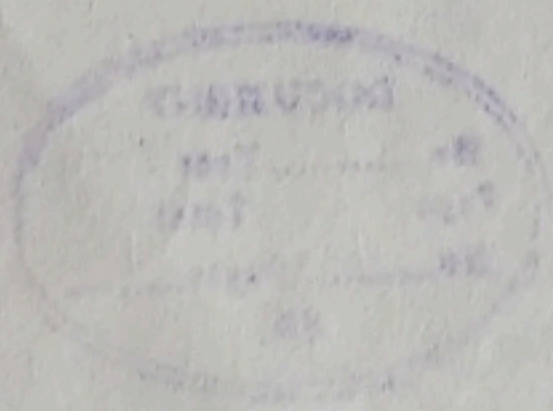

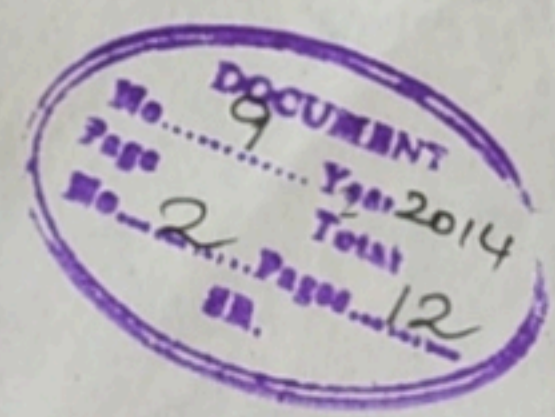
(1) NAME OF THE TRUST

(3) OBJECTS

- a) To organize and implement the social care, developmental, medical relief and charitable projects, homes and programmes for the welfare of children, women, aged, disabled, youth, villagers, slums dwellers, nomads, tribes, beggars, child labourers, bonded labourers, widows, and disadvantaged sections of the society.
- b) To create environmental awareness and educate and motivate the general public to work for the environmental equilibrium such as social forestry, tree planting, waste land management and watershed management.
- c) To hold, organize and arrange meetings, lectures, discussions, seminars, symposia, conferences, competitions, debates, exhibitions, etc., in the fields of social problems, human rights issues, environment and education.

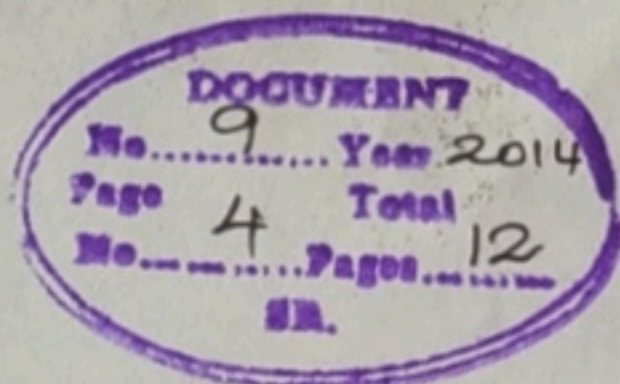

- d) To evolve and implement educational, environmental, human rights and hospitals and health oriented programmes for the underprivileged and weaker sections of the society including women, youth, handicapped, working children, drug addicts, urban and rural poor to enhance their social, and well being.
- e) To establish, promote, set-up, run, maintain, assist, finance, support and or aid in setting up and or maintaining and or running school and other institutions, orphanages, widow homes, human care asylums, houses for poor, or other establishment for relief and or help to the poor, old and infirm people and/or destitute.
- f) To assist by providing monetary and other help assistance for the relief of persons and animal effected by natural and other calamities such as flood, fire, famine, cyclone, tsunami, earth quack, storm, accident, pestilence, drought, epidemic, unbearable cost of living and etc. to give subscription, donation or contribution to organizations, establishments, institutions, centers, or persons doing such relief work on such occasions.

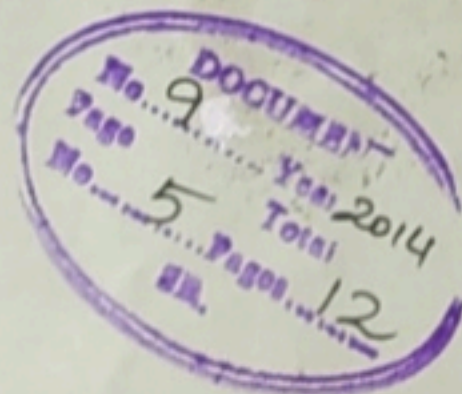

- g) To grant or give scholarship, stipend, prizes, rewards allowance and other financial assistance to students, and to sponsor traveling, boarding and lodging expenses for students going abroad for higher education and training.
- h) To conduct or organize or implement research, training, counselling and guidance, consultancy, publications and documentation in the field of social welfare, human rights, care and social work.

(4) ACTIVITIES IN FURTHERENCE OF THE OBJECTS SHALL BE:

- i. To appeal for funds and receive voluntary contributions aids grants and gifts, membership fees and other assessments locally and overseas.
- ii. To raise income from properties, endowments and investments.
- iii. To receive endowments in cash or in kind and other assets from any other trust or organisation having objects similar to those of this trust.
- iv. To borrow or to raise money at interest or otherwise from Banks or administrative institutions or Financial Institutions or from others and pledge, hypothecate or mortgage the movable and immovable securities of the trust.
- v. To contribute, subscribe and to assist and make gifts to any other trusts or organisations having objects similar to those of this trust.
- vi. To purchase, take on lease or hire or otherwise acquire or hold also to sell, hypothecate, pledge, mortgage, transfer or lease any movable or immovable property or any right to privilege for the purpose of the Trust without the intention of profit.
- vii. To open and operate Bank accounts of any description with any Nationalised or Scheduled Banks on such terms and in such manner as the Board of Trustees may deem fit in respect of the particular funds of the institutions of the trust.
- viii. The Trust herein declares that it shall not undertake any activity of profit. However, any incidental surplus derived from any fund raising activities shall be utilized for achievement of the objects of the Trust.
- ix. The benefits of objects of the Trust would be available and open to the general public irrespective of sex, caste, colour, community, creed, culture, religion, race or without any distinctions.
- x. The activities of the Trust would be confined to the territory of India.

- xi. The activities would be of purely charitable nature not motivated for profit.
- xii. To do all such other things as are incidental or conducive to the attainment of all or any of the objects of the trust.

(5) THE TRUST FUND SHALL CONSIST OF:

- i. The said sum of Rs.1000/- (Rupees one thousand only) endowed by the author.
- ii. All voluntary Donations, Gifts, Corpus, Donations, Legacies, or Grant in cash, cheques, Demand Drafts, Money or Dues, Postal Orders or in kinds accepted by the trustee.
- iii. All money, properties, movable that may be acquired by purchase, gift or donation or otherwise all manner of rights, titles or inheritance over any properties that may be acquired from time to time in the aforesaid manner.
- iv. The income and properties of the Trust whenever derived shall be utilized solely towards the promotion of the objects of the Trust.

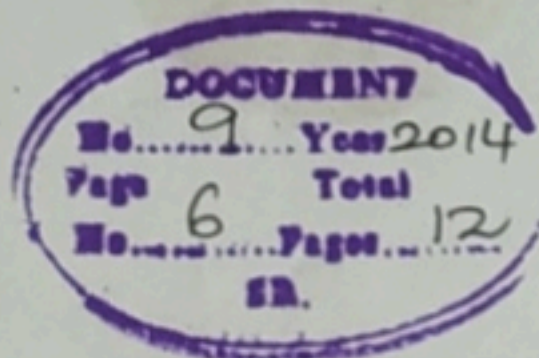
(6) MANAGEMENT OF TRUST

The first Board of Trustees numbers shall not be less than three to administer the trust. It is open to the first Board of Trustees to act as a seven-member by adding four more Trustees.

i) **Mr.J.Paul Peter**, Son of **Mr.Jesupatham**, aged 51years, residing at No.324/2, V.O.C. Street, Poonthottam Nagar, Kakkalur Village & Post, Thiruvallur District, Pjncode – 602003, Tamil Nadu, India, hereinafter called the **Founder and Managing Trustee** of the Trust, and shall hold office for life.

ii) **Mr. Praveen Kumar**, Son of **Mr. P.J.Paul Peter**, aged 23 years, residing at No.324/2, V.O.C. Street, Poonthottam Nagar, Kakkalur Village & Post, Thiruvallur District, Pjncode – 602003, Tamil Nadu, India, hereinafter called the **Founder and Managing Trustee** of the Trust, and shall hold office for life.

iii) **Mr.Prabakaran**, Son of **Mr.John Wesley**, aged 37 years, residing at No.5, Thamarai Street, Poonganagar, Kakkalur Village & Post, Thiruvallur District, Pjncode – 602003, Tamil Nadu, India, hereinafter called the **Trustee** of the Trust, and shall hold office until the Board decides to appoint the new person.

(7) MEETINGS

The Managing Trustee shall convene all the meetings of the Board, whenever s/he considers it necessary. Nevertheless, at least two meetings of the Board of Trustee shall be convened twice in a year.

(a) Notice: Meeting of the Board of Trustees shall be called by giving not less than 7 days notice in writing.

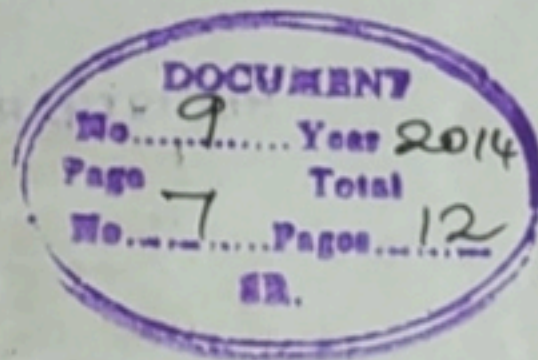
(b) Quorum: The quorum for the meeting of the Board of Trustees shall be three of the trustees personally present at the meeting.

(c) Resolution: The President or Managing Trustee shall preside over at all the meetings of the Board. In his/her absence one of the Trustee present shall be elected to act as a Chairman for that meeting. The Managing Trustee and the Financial Trustee should duly sign all resolutions passed in the meeting. Any resolution passed in the meeting shall be conclusive and be given full effect to. The majority of the Trustees either at the meeting of the Board of Trustees duly constituted or by way of circular shall decide all questions relating to the administration of the Trust. At all meetings of the Board, the resolutions should be decided by show of hands.

Any businesses that require urgent approval by the Board of Trustees shall be transacted by circular among the trustees by the Managing Trustee and the Financial Trustee. Such approval shall be placed at the next meeting of the Board of Trustees for ratification.

(8) ADMINISTRATION

- i. The Board of Trustees shall have the power and authority to administer and manage the trust, its properties and affairs, deeds and things that are calculated to fulfill the objects of the Trust for which the trust is created.
- ii. The Board of Trustees may be conferred any supplementary instrument and provide for such powers as may be required or found necessary for the proper administration of the Trust.

(9) PROPERTIES VESTED IN THE TRUST

- i. Acquisition or alienation of immovable properties of the Trust shall be done with the prior approval of Director/Commissioner of Income Tax (Exemptions).
- ii. The Board of trustees shall hold the properties or funds which may hereafter belong to the trust and expend the income arising thereof for the use and purpose of the trust and the institution if any, under the Trust.
- iii. The trust may receive funds from the Governments, State and Central, National and International foundations, funding agencies, individuals and institutions to implement the objects of the Trust.
- iv. The Board of Trustees shall spend from out of the income thus realized, expend such sum or sums of money as it may deem fit and proper toward the maintenance of the properties of the Trust.

(10) AUDIT AND ACCOUNTS

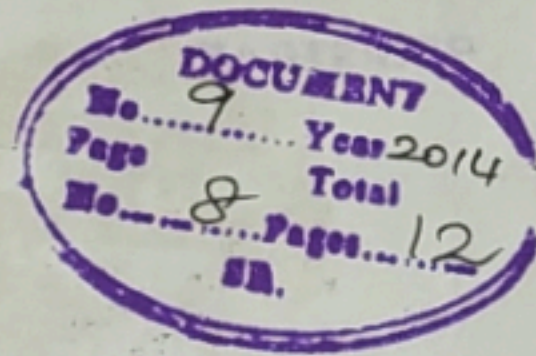
Proper regular books of accounts of the Trust shall be maintained and a Chartered Accountant or firm of Chartered Accountants, approved by the Board of Trustees shall audit the accounts of the Trust. The accounting year of the trust shall be from April to March.

(11) LIABILITY OF TRUSTEES

The trustees shall not be liable for any loss that may be caused to the Trust funds, unless the Trustee is found guilty of fraud or criminal breach of the Trust by competent court of law. Likewise the private liabilities of the Trustees shall not affect the Trust.

(12) APPLICATION OF INVESTMENT AND TRUST FUNDS

- i. The funds of the institution should be utilized only towards the objects and no portion of it would be distributed in any manner to the trustees or persons defined in Section 13 (1) (c) of the Income tax Act, 1961.
- ii. The funds of the institution should be invested as per section 11 (5) of the Income tax Act, 1961.

- iii. Alienation of immovable property shall be done only with prior approval of the Director/Commissioner of Income tax (Exemptions). At present the Trust does not hold any movable or immovable property.
- iv. Not more than 5% of the income of the Trust / Institution would be applied for any religious purposes or given to religious institutions.
- v. The Founder Trustee or other Trustees in their resolutions shall not obtain any benefits whatsoever directly or indirectly from the income of the property of the Trust.
- vi. There is no immovable property in the name of Trust at the time of registration.

(13) DURATION OF THE TRUST

The Trust/ Institution is irrevocable

(14) AMENDMENT OF THE TRUST DEED

The Trust deed may be amended by a resolution passed by a majority of not less than two thirds of the trustees. The Managing Trustee shall circulate such an act of amendment proposed and seconded by any trustees to all the members of the Board of the Trustees, before 7 clear days, prior to the meeting of the Board of Trustees. Any amendment to the existing instrument of the Trust would be carried only with the prior approval of the Director/Commissioner of Income Tax (Exemptions) concerned.

(15) DISSOLUTION

In case of winding up/dissolution, the net funds and properties would be transferred to the Trust / Institutions having similar objects and enjoying exemption under Section 11 and 80G of the Income Tax Act, 1961.

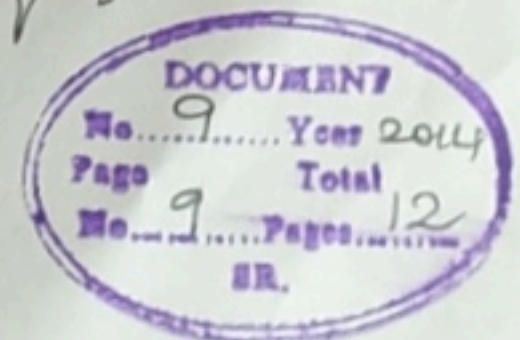

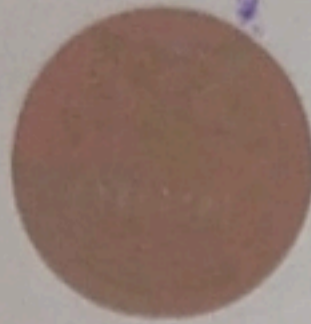
